



Meeting of the Board of Directors Tuesday, May 16, 2023 6:00pm

On Feb. 28, Governor Newsom ended the COVID-19 State of Emergency. As was discussed at the January board meeting, as of March 1, charter school boards must adhere to the traditional Brown Act rules for governing board meetings. *Boards must meet in-person or in a hybrid fashion using standard teleconferencing rules under the Brown Act.*

Pursuant to the State of California's Ralph M. Brown Act, the regular meeting of the GPA Board of Directors scheduled for Tuesday, May 16, 2023, at 6:00 p.m., will be conducted in person at the GPA Dining Hall.

In compliance with the recent passage of Assembly Bill 361 legislation to facilitate public meetings, the GPA Board of Directors will provide an opportunity for the public to address the board in real time during future board meetings, even if those meetings are held via teleconference.

The GPA Board of Directors will allow public comment during each agenda item and will limit each speaker to no more than (2) minutes each at or just before the time the Board hears that agenda item. If comments are in Spanish or another language, such comments will be limited to four (4) minutes to provide for simultaneous translation.
