GPA BOARD OF DIRECTORS' MEETING

September 20, 2016 - 5:00 p.m. GPA Wingspan; Cecil H. Steppe Presiding

CALL TO ORDER:

The meeting was called to order at 5:01 p.m. by Mr. Steppe. He asked for any public comments. There were none. Board members reviewed the agenda items and minutes from the May 17, 2016 board meeting.

CHAIRMAN'S REPORT:

DIRECTOR'S REPORT:

Director Riveroll welcomed everyone to this new school year and thanked the board members for their continued service. He then went through the events that have occurred since staff returned on August 22. It began with 6th grade Commitment Day where the students made their commitments to achieve college in their future. Additionally, there was an evening in August where 114 seniors were inducted into their senior year at Senior Convocation. The first day of school had 1,252 students in attendance with a 98% attendance rate. Upcoming events include: Open House this Friday where Senior Magic fundraising show will occur, and our WASC visit Oct. 30-Nov. 1. After the business part of the meeting concluded, board members were treated to a taste of the "Senior Magic" performance.

FINANCE COMMITTEE REPORT:

A. Mr. Chodzko highlighted that GPA finished the year incredibly strong. Net income for 2015-16 was \$910,200, which was above budget by \$592,125. Enrollment and ADA was 46.95 more than budgeted. GPA received a Career Technical Education Incentives Grant of \$120,188. The board discussed how GPA raised ADA and how that impacted finances.

E. <u>Campus Security Cameras:</u> request to the Finance Committee for these cameras, which need updating to help identify people and items taken in a break in. These are high definition cameras that would allow proper safe viewing of our site. These cameras will also assist the front office staff, as well, to know who's walking into the main office. Cost is \$22,141.00

F. <u>Purchasing of 216 Chromebooks:</u> to provide access for our students to have 1 to 1 laptop program and would require training for students and parents. This would give our students the tools needed to be successful. Cost \$48,299.76

G. Auditorium Upgrades: OID has a request to upgrade the auditorium, which would allow us to upgrade our lighting with LED lights that change colors easily. Rental fees now are \$25,000 to \$30,000 per year. This will also provide a student job training opportunity. Cost is \$135,704.20
