CALL TO ORDER:

The meeting was called to order at 5:13p.m. by Mr. Steppe. He asked for any public comments and there were none. Board members reviewed the agenda items and minutes from the January 17, 2017 board meeting.

CHAIRMAN'S REPORT:

DIRECTOR'S REPORT:

- Board watched a tribute video to Lucy Killea's Legacy and contributions to GPA.
- On March 10, 2017 the United States Citizenship and Immigration Services presented at GPA Parent Preparatory Academy on immigration and answered questions and concerns from parents, students, staff and community members.
- GPA class of 2017, Coast Guard appointee, Ruben Castillo-Delgado is currently visiting Coast Guard Academy in Connecticut.
- Several male students have begun attending ballet classes at the Scripps Performing Arts Academy.
- Two GPA students are participating in San Diego Junior Theater and are starring in musicals at Balboa Park.
- Director discussed the college acceptance data at GPA. Since 2012, we have seen an increase from less than 40% to almost 90% acceptance percentages for seniors going into 4-year universities.
- Eleventh grade student, Muhammad El-Arbi, was one of 100 students in the United States who was selected to participate in the Disney Dreamers Academy.
- As a gift of gratitude to the GPA staff, the staff lounge and copy room were updated.

- Currently, fifty-one seniors have been accepted to UCSD. The Board watched the class of 2017 "wing" ceremony, which was performed at the high school honor roll, highlighting the 99 seniors who have been accepted to a 4-year university.
- Coming up at GPA, on April 7, 2017 State Assemblywoman, Lorena Gonzalez-Fletcher will be visiting campus.
- Twenty-three students in grades 6-11 are participating in The League of Amazing Programmers, a 5-year program that ends with Java programming certification.
- Dr. Mehan thanked Director Riveroll for all of the hard work behind all that has been accomplished by Gompers Preparatory Academy.
